3. **REGISTRATION OF TEAMS**

- 3.1 All teams shall be registered for the competition through the official email of the National federation of each country duly signed and stamped for by President/Secretary General.
- 3.2 Number of teams, per gender, per federation
- 3.2.1 The Leg will accommodate a maximum of 32 teams per gender for the competition.
- 3.2.2 Being the 1st Leg, the zone will grant for each country 3 automatic slots per gender in terms of each federations own ranking. To the host the zone grants 5 slots.
- 3.2.3 Each national federation shall be allowed to register up to 5 teams per gender and clearly rank the teams in order of each federation's rankings.
- 3.2.4 Where by the set deadline below any federation has failed to submit its teams the remaining slots will be shared in equal proportion amongst the federations that would have registered and confirmed their teams as set

below. The sharing of slots that arise in each gender category will continue to be distributed using the submitted ranking of teams for each Federation until all slots are filled

e.g If after the first three automatic slots are taken and there remains extras due to none uptake then the slot allocation will move from three to four and so on in each gender until either the slots are finished or there are no more teams on the registered list of each national federation

- 3.3 National federation shall submit its team registration form by 30 November 2021. Form must be submitted in 2 format, scan signed and stamped by national federation and electronic editable version to be used on the B-VIS.
- 3.4 National Federation must submit each team final confirmation together with proof of payment of the affiliation by close of business on 15 December 2021 failing which any registration by way confirmation letter from National Federation shall be deemed forfeit and the slot deemed free.
- 3.5 Failure to attend the competition after completion of 3.4 above then that team shall forfeit the affiliation fee and maybe be subject to further penalties from the Zone.
- 3.6 During the preliminary inquire meeting teams must present the followings:
- 3.6.1 Original of registration Form duly signed and stamped by the national federation.
- 3.6.2 Original prove of payment of the registration fee.
- 3.6.3 Passports of all players (the host can present the original of ID card).
- 3.6.4 All uniform that they intend to use during the competition.

4. REFEREES

- 4.1 The Zone shall be responsible for the transportation of referees by road from their country of origin and back to the competition including their upkeep during the competition. National Federation who can offer to transport the referees will be welcomed but have to inform the zone of their intention via their National Federation.
- 4.2 National federations must send to the zone the full list of their International BVB Referee (IR), International BVB Candidate Referee (CIR) or National BVB Referee (NF) by 15 November 2021.

- 4.3 Such list must contain the followings information's: Name of the referee, FIVB Number, category of referee (IR, ICR or NR), gender, WhatsApp number, email.
- 4.4. The list must be started with IR, followed by the ICR and them the NF all those ranked based on the view of the NF of his ability and quality (technical and personal behaviour) that will help the zone to nominate them.
- 4.5 Referees nominated by the zone will be required to sign a contract with the Zone for due performance and remuneration and transport conditions which will be subject to the level of each referee.
- 4.6 Where Federations do not appoint such a referee by the said date then the Zone shall at it discretion appoint same from the pool of referees available to it.
- 4.7 The referee allowance will be:
- 4.7.1 IR USD 35.00 per competition day including preliminary inquire day.
- 4.7.2 ICR USD 30.00 per competition day including preliminary inquire day.
- 4.7.3 NR USD 25.00 per competition day including preliminary inquire day.
- 4.8 The Zone will only cover the allowance of referees nominated by them. All other referees will be under the respective National Federation.

5. TEAMS UPKEEP

- 5.1 It is the responsibility of Teams to secure accommodation and upkeep for their Clubs and all costs associated with movement to and within Mozambique.
- 5.2 A list of available accommodation has been circulated to each Federation and the host will provide a contact person for all logistics the Clubs may seek to have assistance with.

6. VISAS AND TRAVEL REGULATIONS

- 6.1 Please treat this letter as the official invitation to the competition. The Mozambique Volleyball Federation will provide a further invitation letter as the competition draws close for visa purposes.
- 6.2 All Clubs are encourage to familiarise themselves with Covid 19 travel conditions and visa requirements as provided for in Circular **No. ZoneVI/CC/21** issued out on 28 April 2021. The Mozambique Volleyball Federation will provide futher information on the Covid-19 protocols imposed by the country while all teams must comply also with the FIVB Covid-19 protocol attached.
