PLAYER & CLUB REGISTRATION ON THE FIVB PORTAL

Please take careful note of the registration procedure of clubs and players on the FIVB portal. **Assistance in this regard will be given by VSA Treasurer Vinesh Maharaj to those who may experience some difficulty during the registration process.

REGISTRATION PROCEDURE

Phase 1: **REGISTRATION OF CLUBS**. This process must start immediately and end on or before 18 February. A ***registration format** is supplied, **fill on line and forward to the VSA office**.

Phase 2: Clubs will receive their **PASSWORD on 18 February** to register their players on the FIVB Registration Portal.

Phase 3: Clubs to **register their players** from **19 February to 28 February** 2022 on the FIVB registration portal.

Phase 4: VSA office will send all the team sheets back to the provinces for **verification by 15 March**. Provinces to send lists to individual clubs to assist in the verification process.

Phase 5: Provinces to forward a **list of all their clubs on excel** to the VSA Office (for VSA's database)

NB. 1. Provinces to **appoint a dedicated official** to take **charge** of their respective **registration** process. The provincial registration official will liaise with the VSA Office and the VSA Treasurer as the FIVB will not entertain any queries regarding registration from players or officials from member countries other than from the National Federation, in our case from VSA only. All communication with the FIVB and CAVB will be conducted via the VSA Office.

REGISTRATION OF FOREIGN PLAYERS (having an ITC is a must)

- A foreign player must first be registered in his/her country of origin, even if the said player has lived in South Africa for decades or has not played volleyball in his/her country of origin (this a new ruling from the FIVB).
- A foreign player must take care of his/her own registration process.

NB. 1. Player registration CLOSES on 31 March.

2. Window period for TRANSFERS is from 1st to 31st August

3. The registration of new players (those who did not play club volleyball previously) can be registered through out the year.
